**1. Call Meeting to Order.**

**2. Consider/action awarding bid for the Alamo Street Water and Sewer Project.**

City Manager Mark Mayo stated that our engineer had sent a letter stating that he reviewed the 2 bids that were received and that they meet all the standards. The low bidder of the project is G5 Utilities LLC with a bid of \$222,970 for the Water and Sewer Project.

Council Member Lee Rust questioned why there wasn't a fire hydrant in the project and City Manager told him that the fire hydrant on Austin Street is close enough to use.

Council Member Lee Rust made a motion seconded by Council Member Jackie Campbell to award the Alamo Street Water and Sewer Project to G5 Utilities. The motion carried with all members present voting unanimously in favor of the motion.

**3. Consider action an ordinance adopting a budget for the ensuing fiscal year beginning April 1, and repealing all ordinances or parts thereof in conflict herewith.**

Council Member Jackie Campbell made a motion seconded by Council Member John Wells to postpone agenda item #3 to the next Special meeting next week. The motion carried with all members present voting unanimously in favor of the motion.
