SPECIAL NOTE: All decorations and/or trash must be removed and disposed of in the dumpster located outside of the pool area.

Lessee agrees to abide by the following rules and regulations as they pertain to the rental of the Southside swimming pool.

- 1. The safety of our swimmers is our main goal. If you invite more than 50, you will be required to inform the City beforehand in order to have sufficient lifeguards on duty. There will be an additional charge of \$25.00 per lifeguard.**
- 2. The damage deposit must be paid upon reservation of the facility. A signed acknowledgment of the rules must accompany the rental contract along with the rental fee prior to the use of the facility.**
- 3. Decorations and/or trash must be removed by the Lessee immediately following the event. Failure to remove decorations and/or trash from the event may result in a deduction from the damage deposit.**
- 4. The Lessee agrees to be assessed for any and all damages to the facility during the rental period; and consents to a reduction in the return of the deposit for said damage. The deposit will be returned upon the satisfactory inspection of the premises.**
- 5. Glass containers are prohibited in the pool area.**
- 6. Do not block exits. They must remain clear at all times for emergency fire exit purposes.**
- 7. The City of Luling is not responsible for any damage or loss of any property, vehicle, or equipment while on the premises wither as a lessee, visitor, or contractor.**
- 8. LESSEE ACCEPTS AND ASSUMES RESPONSIBILITY FOR THE BEHAVIOR OF THOSE WHO ATTEND THE FUNCTION.**
- 9. Lessee, by execution of this agreement, acknowledges that he/she has read all terms and conditions expressed herein and all attachments hereto and fully understands their meeting and effect.**
- 10. Lessee agrees to abide by posted pool rules as well as lifeguard instruction.**
